#### **Motions**

Dima Thompson made the following motion: "The Communications Committee recommends the trial Oronoque Village Facebook Page and the name OV Connections is to no longer be used and is no longer affiliated, supported, administered or connected to OVCA, and that all posts will be deleted effective at a date to be determined by OVCA."

The motion was seconded by Bob Romatzick.

After a number of comments were made by members of the Board, Dima Thompson withdrew the motion and Cheryl Dwyer made a new motion as follows: "The board will continue to operate OV Connections under the existing guidelines. From this day forward, any resident with two violations of the guidelines will lose his/her rights to use OV Connections. This site will be solely administered by the Executive Director and his designated office staff employee." The motion was seconded by Jerry Brown and was passed with a unanimous vote by the Board.

Larry Hartley made a motion to approve the addition of a patio at 475A Commanche Lane. The motion was seconded by Cheryl Dwyer and was approved unanimously.

Upon review of the proposed Rules and Regulation, a motion was made to correct the Maintenance Standards to change carbon dioxide alarm to carbon monoxide alarm. The motion was made by Lee Shlafer and seconded by Larry Hartley. The motion passed with a unanimous vote of the Board. (All of the proposed revisions were reviewed and will now be sent to the unit owners for their comments.)

**New Business:** A short explanation of the proper approach for bringing a motion to the Board was given. A district representative may bring up any issue at an OVCA Board meeting even if it is not on the agenda, however, no motion may be proposed and a vote taken unless the matter is on the agenda. The reason for this is that our by-laws require that notice be given to Unit Owners about OVCA meetings and that includes notice of items that may be voted upon. With respect to the motion that was made at the January OVCA meeting involving SAC, Lee Shlafer spoke to attorneys at Cohen and Wolfe, who said the motion could stand because there was a full Board present at the meeting.
