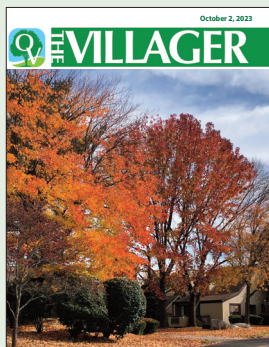

6. Check with the Connecticut Dept. of Consumer Protection (860-713-6100) to see if there are any negative reports regarding a vendor.
